Whereas by Government Notification No. 23/31/2004-RD dated 10-03-2006 published on pages 1262 & 1263 of Series II, No. 51 of the Official Gazette, dated 23-03-2006 and in two newspapers (1) "Herald" dated 15-03-2006 and (2) "Pudhari" dated 16-03-2006 it was notified under section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (hereinafter referred to as "the said Act") that the land specified in the Schedule appended to the said Notification (hereinafter referred to as the said land), was needed for the public purpose, viz. Land Acquisition for Construction of 800 m3 Ground Level Reservoir at Cotombi in Bicholim Taluka.

And whereas, the Government of Goa (hereinafter referred to as "the Government") being of the opinion that the acquisition of the said land is urgently
